#### The New Jersey Law Against Discrimination in Housing

All New Jersey residents and those seeking housing have the right to an experience that is free from discrimination. This training will provide an overview of the New Jersey Law Against Discrimination (LAD) and review housing protections under the LAD. Through case studies and other interactive exercises, participants will examine topics including source of lawful income discrimination, steering, sexual harassment, reasonable accommodations, and service and support animals.

Resident Preparedness Receptions: PRD - Personal Responsibility in Disasters (Help can be delayed, so.... Make a Kit, Have a Plan, Stay Informed)

This lunch and learn can be tailored for the following audiences: building tenants, residents independent living communities and/or employees. History has taught us that in a wide-scale catastrophe, help is delayed. The messaging of this program emphasizes to attendees on behalf of property owners and administrative staff: "In an emergency, YOU are responsible for the health, safety and comfort of your family...here's how in 3 Key Steps". Takeaways include checklists, and tactics that are proven to keep communication open despite power disruption, the biggest obstacle to recovery in the early hours of a crisis. Administrators, Facility Managers and Resident

Coordinators appreciate this program because when residents take responsibility for themselves, the burden of "the people part of the disaster" is greatly reduced during a crisis. For employee groups, this training is particularly important, because when matters are handled at home, employees are then able to return to their post and assist with their organization's recovery efforts.

#### HOTMA Section 103 - Are You Complying?

HOTMA Section 103: Limitations on Public Housing Tenancy for Over Income Families
This requirement went into effect on June 14, 2023. Housing authorities are to be noticing PH residents
whose income has exceeded the over-income provisions of HUD. Attendees will learn about all Section 3
requirements, the elements of each of the notices, and will also be instructed on what actions to take
once the 24-month tenancy grace period has expired.
